### Countries and delivery times

Shorter times generally apply to towns and cities. Export on the day of collection is possible for volumes of approx. 15 parcels and above per day. This generally reduces delivery times by one working day.

### Customs clearance costs

Customs clearance costs are based on the inco-term label, which also regulates the distribution of costs between the exporter and importer. The exporter pays the cost of transport.
