

Electronic cash on delivery (BLN)

Simple, practical and secure

You send COD consignments and are looking for a solution that simplifies shipment preparation, ensuring that your parcels will be delivered safely to their recipients and COD payments will be collected.

Simple handling

The electronic cash on delivery service from Swiss Post is very easy to use: the consignment simply needs a consignment barcode, the BLN value-added service barcode and a valid recipient address.

Transmission of consignment data

You transmit your shipment data (consignment number, recipient address and COD amount) to Swiss Post electronically for each consignment using one of the following options:

- “Barcode” API module
- “Domestic parcel labels” [online service](#)
- “WebStamp” [online service](#)
- DataTransfer (www.swisspost.ch/datatransfer)
- “Barcode” web service (www.swisspost.ch/web-service-barcode)

With parcel consignments you can also notify the recipient of the delivery day and the COD amount via SMS.

For letters, the data can only be submitted via WebStamp or DataTransfer; submission is not possible for the other services.

Guaranteed payment

The recipient only receives the COD item once they have given the confirmation of receipt for it and paid the amount due. The maximum COD payment amount is CHF 10.000. The full COD amount is then credited to your postal or bank account.

Efficient payment method

With electronic cash on delivery (BLN) you receive payment quickly and securely, since your goods are only handed over to recipients once they have paid the amount due.

Electronic cash on delivery (BLN) therefore is a cost-effective and secure alternative to payment by invoice or by credit card. You have none of the administrative expense associated with payment reminders or debt collection.



Advanced Track & Trace

Via the “Track consignments Business” [online service](#) you have access to advanced consignment tracking features and can view the name and confirmation of receipt of the recipient.

What’s excluded

Electronic cash on delivery (BLN) is not possible with the following consignments: international consignments, small consignments, direct parcel posting, Swiss-Express “Innight”, SameDay afternoon, SameDay evening, Swiss-Courier “Permanent”, PostPac Promo.

Please note:

- The maximum COD payment allowed is CHF 10.000
- Using the “AdressChecker” API module is recommended

Electronic registration of consignments and transmission of consignment data



Electronic COD items have to be registered and the consignment data transmitted using one of the following systems:

- “Barcode” API module
- “Domestic parcel labels” or “WebStamp” online services
- “Barcode” web service
- DataTransfer

Mailing

Mail electronic COD items with the basic service selected.

Delivery

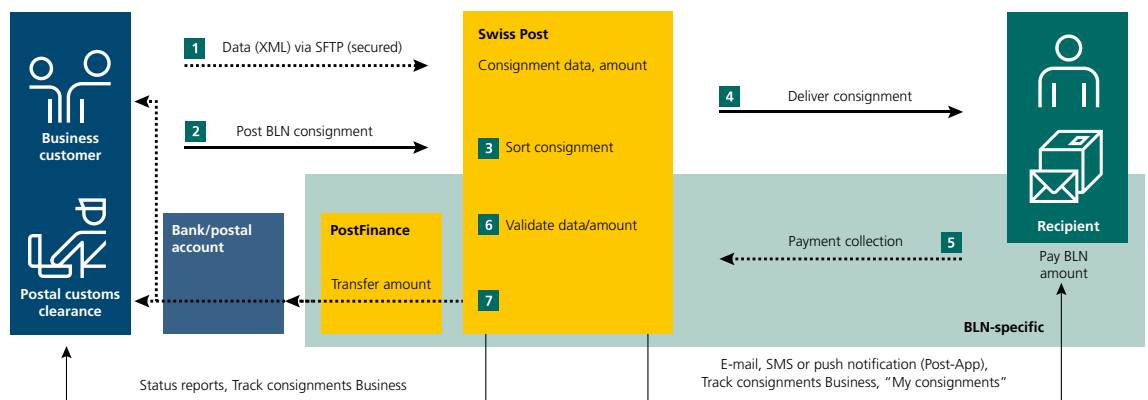
- Letters: Monday to Friday
- Parcels: Monday to Friday. May also be available on Saturday depending on the chosen service
- Always against confirmation of receipt and payment of the COD amount
