Invoice code 461 When taking goods to an upper floor, cellar, etc., a surcharge is charged per 100 kg of weight subject to freight charges (minimum CHF 30.00 per consignment). The surcharge is payable if the driver cannot transport the goods into a warehouse via a ramp, or if the recipient cannot take delivery of the goods directly from the vehicle's hydraulic lift (kerb-side). Floor Deliveries can be executed for packages with a weight up to 25kg (SUVA guideline) and dimensions which allow the carriage by a person. If there is a goods lift, which can be used by pallets respectively Hand pallet trucks, also larger packages can be delivered to the desired floor. Deliveries to private persons are made exclusively to the kerb-side

The exchange of load carriers is chargeable and is 4% of the invoiced transport turnover.

The service fee for the use of frames, lids and new pallets and for cross-border operations is 8%. This fee will be stated separately on the transport invoice. If the balance is settled in CHF, the value of a used container is charged. The aforementioned percentage surcharges apply to the mutual exchange service. If the packaging cannot be mutually exchanged, a freight fee based on the chargeable weight (plus any additional services) will be charged for the separate collection in accordance with the agreed customer conditions. An order must be placed for conduction of a mutual exchange. If no such order is placed, Swiss Post shall assume that no mutual exchange is necessary and that the packaging will in each case be sold to the recipient with the goods.
