# **CROSS-DOCKING OUTSOURCE YOUR INTERMEDIATE WAREHOUSING**

With cross-docking, we check incoming goods, repackage them, combine them with goods from other suppliers and prepare them for onward shipment. Crossdocking enables you to greatly simplify your logistics. You can even outsource all your intermediate warehousing.

# IT + cross-docking = no intermediate warehousing

Thanks to sophisticated IT, logistics with cross-docking allows goods from one or more manufacturers destined for one or more recipients to arrive in our logistics centre at the same time. We then perform incoming goods and quality checks, repackage the items, combine goods from different senders into consignments for the various recipients, and prepare them for onward shipment, usually within 24 hours. The goods are not stored with cross-docking.

For example, the company Elektronik-Handels AG has 14 branches spread across Switzerland. It arranges for the DVD/HD recorders of manufacturer A from its factory in Ireland and the Blu-ray disc players from the same manufacturer, but from a different factory in Portugal, plus the MP3 players of manufacturer B and the digicams of manufacturer C to arrive at our logistics centre in Dintikon at the same time. We check the goods, repackage them, assemble the shipments (consisting of DVD/HD recorders, digicams, MP3 players and Blu-ray disc players) for branch 1, branch 2, etc. and get them ready for onward shipment – all within 24 hours! Thanks to cross-docking, Elektronik-Handels AG can manage without a central warehouse. In addition, it cuts down the manufacturer-to-branch time, making the whole process more cost-efficient.

#### The advantages of lean logistics

 You can hand over the entire flow of goods from the producer to the end consumer to a single partner – Swiss Post – without having to touch the goods even once. With cross-docking and an electronic merchandise information system, you can even eliminate the need for your own warehouse

- Your set-up/warehouse capacities need not be designed to cope with rarely occurring peaks
