

CONSIGNMENTS TO THE BORDER AREAS BÜSINGEN, CAMPIONE D'ITALIA AND SAMNAUN

PROVISIONS AND PARCEL OFFER

Specific provisions may apply for mailing documents and goods to certain border areas in neighbouring countries, viz. Büsingen, Campione d'Italia and Samnaun. This concerns prices and franking in particular, partly also labelling. Please observe those provisions. Here you will also find an overview of the available parcel, express and SameDay services for shipping from Switzerland.

Provisions for Büsingen

Goods from Switzerland to Büsingen

- Parcel consignments must have a domestic parcel barcode.
- The basic services Swiss-Express "Moon" and SameDay afternoon / evening are excluded.

Prices

Domestic prices for Switzerland apply (no accompanying documents required).

Goods from Büsingen to Switzerland

Prices

- Domestic prices for Switzerland apply.
- Exchange rate for both currencies: at the current exchange rate of the local financial institution
- Price details: from the postal establishment (post office) in Büsingen

Franking

With postage stamps or an alternative procedure authorized by Deutsche Post AG only



Goods from Campione d'Italia to Switzerland

Prices

Domestic prices for Switzerland apply.

Franking

With Italian stamps only.

Provisions for Campione d'Italia

Goods from Switzerland to Campione d'Italia

- Parcel consignments must have a domestic parcel barcode.
- The basic services Swiss-Express "Moon" and SameDay afternoon / evening are excluded.

Prices

- Domestic prices for Switzerland apply (no accompanying documents required).
- For postage-free consignments within the Swiss domestic postal service domestic prices for Switzerland apply.

Provisions for Samnaun

Goods from Switzerland to Samnaun

- Parcel consignments must have a domestic parcel barcode.
- The basic services Swiss-Express "Moon" and SameDay afternoon / evening are excluded.

Declaration of contents of consignments / commercial invoice

- For consignments of goods worth up to CHF 1,000.00: with customs declaration CN 22, commercial invoice recommended (affixed on the outside of the consignment)
- For consignments of goods worth over CHF 1,000.00: commercial invoice compulsory (affixed on the outside of the consignment)

SWISS POST 

Sender's address

The consignment must specify the sender's address in full, including telephone number.

Labelling of consignments

The consignments must be labelled with an "Export Clearance" sticker.

Consignments registered for export electronically (e-dec)

- For these consignments an export list is compulsory (affixed outside of the consignment).
- The consignments must be labelled with a "E-DEC EXPORT" sticker.

Goods from Samnaun to Switzerland

Prices

Domestic prices for Switzerland apply.

Customs declaration

A customs declaration is required for parcels.

Import customs clearance

Postal consignments from Samnaun to Switzerland with a goods value of CHF 65.00 or more (at a VAT rate of 7.7%) or CHF 200.00 (at a VAT rate of 2.5%) require import customs clearance (as with normal import provisions).

Customer refuses delivery

Goods exported from Switzerland which are returned unchanged to the sender in Switzerland can be reimported into Switzerland duty-free provided that the value added tax represents less than CHF 100.00.

If a recipient in Switzerland refuses a parcel from Samnaun, it will be sent back to the sender. In this case, no taxes, fees, state duties or customs clearance charges will be levied in either direction.

Repairs

Samnaun–Switzerland

Goods of Swiss origin sent back to Switzerland for repair will be imported duty-free provided that the value added tax represents less than CHF 100.00.

The repair costs must be specified in detail on an invoice enclosed with the return shipment. The VAT will be reimbursed to the recipient in Samnaun (provided that they are not entitled to input tax deductions).

Switzerland–Samnaun

If items are sent from Switzerland to Samnaun for repair, consignments must be declared as passive repair traffic for export purposes.

Goods that have been repaired in Samnaun are liable to customs duties when being imported into Switzerland, and the repair costs are subject to VAT. (Exception: warranty repairs)
