As part of the annual review of the range of the services offered by Post CH Ltd, the following amendments to the products and prices within the private customer range will take effect from 1 January 2017.

The changes to letter services – national

Registered and A Mail Plus

- Registered and A Mail Plus are now independent products and no longer A Mail value-added services.
- The measures lead to price reductions except for standard format registered mail (B5 format up to 100 g).
- Introduction of a price differentiation for consignments according to franking and barcode labelling (handling surcharge plus CHF 1.00 for missing/incomplete franking and/or without barcode labelling).

A and B Mail format surcharge B5 up to 5 cm

- Standard and midi letters in B5 format over 2 and up to 5 cm thick can now be sent as a letter with a format surcharge.
- Until now, parcel prices applied to consignments over 2 cm. Large letters (B4 format) thicker than 2 cm are still considered as parcels.
- The liability provisions remain the same.
